

TERMS & CONDITIONS - PIZZA DAY GIVEAWAY (DAY 1)

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility:

The Pizza Day Giveaway (the "Promotion") is open only to individuals who are at least eighteen (18) years of age (or the age of majority in their jurisdiction of residence, whichever is older) at the time of entry. By entering the Promotion, the contestant ("You") agree to comply with and abide by these Rules and the decisions of the Robinhood Crypto ("Sponsor"), and you represent and warrant that you meet the eligibility requirements. In addition, you agree to accept the Sponsor's decisions as final and binding as it relates to the content of this campaign.

Exclusions: Employees, officers, and directors of Sponsor, its affiliates, subsidiaries, advertising and promotion agencies, and their immediate family members are not eligible to participate. The Promotion is only open to those who reside in the United States and is void where prohibited or restricted by law.

2. Promotion Period:

The Promotion begins on May 22, 2026 at 2:00pm Eastern Time and ends on May 25, 2026 at 11:59pm Eastern Time (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Promotion.

The Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Promotion at any time.

3. How to Enter:

During the Promotion Period, you may enter the Promotion via X by commenting on the official Promotion post with a brief answer to a prompt.

Limit: One (1) entry per person/X account during the Promotion Period. Multiple entries using multiple accounts or automated methods will result in disqualification.

5. Winner Selection and Notification:

On or about May 26, 2026, Sponsor will randomly select 3 potential winner(s) from among all eligible entries received. The odds of winning depend on the total number of eligible entries.

The potential winner(s) will be notified via Direct Message (DM) on X within 4 days of the drawing. The potential winner must respond to the DM within forty-eight (48) hours

to claim the prize. If a potential winner cannot be contacted or fails to respond within the required time period, an alternate winner may be selected.

6. Prize(s):

Three winners will each receive a pizza oven and pizza kit valued at about \$800 USD (the "Prize"). Actual/appraised value of prizes may differ at time of prize award. The specifics of the prize shall be solely determined by the Sponsor. No cash or other prize substitution shall be permitted except for at the Sponsor's discretion. The prize is non transferable. Substitution of the prize or transfer/assignment of the prize to others or request for the cash equivalent of the prize by the Winner is not permitted.

7. Taxes and KYC Requirements:

All federal, state, local, and other taxes on the Prize are the sole responsibility of the winner. If the ARV of the Prize exceeds certain thresholds (e.g., \$2000 USD), the winner may be required to complete and submit an IRS Form W-9 (or equivalent tax form in their jurisdiction) and pass a Know Your Customer (KYC) identity verification and sanctions screening check before the Prize is distributed. Failure to pass KYC screening will result in forfeiture of the Prize.

8. General Conditions and Release:

By participating, entrants agree to abide by these Official Rules and the decisions of the Sponsor, which are final and binding. By accepting the Prize, the winner agrees to release and hold harmless the Sponsor, X Corp. This Promotion is in no way sponsored, endorsed, administered by, or associated with X Corp. (Twitter). You are providing your information to the Sponsor and not to X Corp.

10. Governing Law and Disputes:

If unresolved, all disputes (excluding intellectual property claims seeking injunctive relief) will be settled via binding, individual arbitration under American Arbitration Association (AAA) consumer rules. By participating, you waive your right to a jury trial and your right to participate in any class action lawsuit or class-wide arbitration. These Official Rules shall be governed by and construed in accordance with the laws of California and the United States, without regard to its conflict of law principles. Any recovery is limited to actual

out-of-pocket costs incurred to enter the Promotion. You waive all rights to claim indirect, punitive, incidental, consequential, or multiplied damages, and attorney's fees.
