

Sherwood Media Terms & Conditions

As used in these Terms & Conditions, “Sherwood” means Sherwood Media, LLC (“Sherwood” or “Sherwood Media” or “Company”) and its in-application and web experience with its family of affiliates, including Robinhood Markets, Inc and its affiliates (“Robinhood”), Robinhood Financial LLC (“Robinhood Financial”), Robinhood Securities, LLC (“Robinhood Securities”), Robinhood Crypto, LLC (“Robinhood Crypto”), Robinhood Money, LLC (“Robinhood Money”), Chartr Limited (“Chartr”), Robinhood U.K. Ltd (“Robinhood UK”), Robinhood Derivatives, LLC (“Robinhood Derivatives”), Robinhood Gold, LLC (“Robinhood Gold”), and Robinhood Credit, Inc. (“Robinhood Credit”).
